Items 1 & 2 Mrs. Garza called the meeting to order at 7:00 p.m., after noting a quorum was present and that the meeting notice had been posted as required by law.

Item 3 ROTC Color Guard led in the Pledge of Allegiance.

Item 4 Welcome/Open Forum:

Community Member/Parent Hoss Lozano made public comments regarding the 2007-2008 Annual Performance Report.

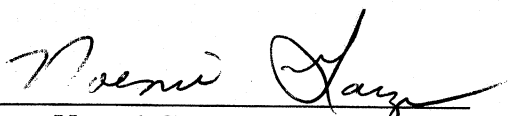

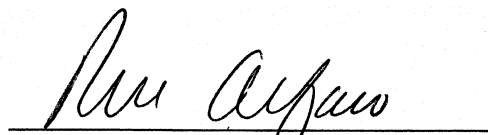
Consider Approving Addendum to the Substitute Teacher List for the 2008-2009 school year.
